






# A demographic 'Leaky Bucket' is contracting total student volume, yet private sector revenue surges as parents vote with their feet

## The Great Migration (2-Year Shift)





2024 Market Value




Value Bridge 2024 to 2030E



### The Great Filter: Regulatory Risk

- ⚠ **Dummy School Crackdown:** 150+ CBSE affiliations revoked in 2024.
- ⚠ **Consolidation:** 15-20% of sub-scale schools expected to close/merge (2025-28).
- ⚠ **PE Red Flag:** Schools with no physical campus or high teacher attrition.







## OpCo-PropCo Model

### PropCo (For-Profit)

- Owns Real Estate & IP
- Absorbs CapEx
- Collects Lease/Mgmt Fees



### OpCo (Non-Profit Trust)


- Runs Academics



- ✓ Deconstruct Roles: Hire '**Masters of Practice**' for vocational dignity.
